Bids are requested for the supply, installation, testing & commissioning of new Ro Plant (500 LPH) in Student's Boy's Hostel of AIMK, and pipe line to be extended to each floor (G+7), and RO Plant should be shaded by tinsheet, in accordance with the attached scope of work (Point12). Interested vendors are asked to submit their bids physically, with ink signatures, in sealed envelopes. The envelope should be clearly labelled with 'REQUEST FOR PROPOSAL FOR SUPPLY, INSTALLATION, TESTING & COMMISSIONING OF RO PLANT FOR BOY'S HOSTEL, ARMY INSTITUTE OF MANAGEMENT, KOLKATA'. 1 Capacity and Performance:

- Type: Reverse Osmosis (RO) Water Treatment Plant
- Capacity: 500 Liters per Hour (LPH)
- Input Water: From Client Source
- Output Water: Treated potable water with TDS reduced as per WHO standards

- Recovery Rate: Minimum 50% recovery of input water
- 2. Components: (Minimum)
  - Pre-filtration Unit:
    - o Iron removal filter
    - Activated Carbon Filter
    - Double Micron Filter
  - **RO** Membrane
  - Antiscalant Dosing System: To prevent scaling on membranes •
  - Added Mineral system

- 3. Pipeline Layout:

7. Water Test report from a NABL accredited lab is required after commissioning/final implementation.

Delivery Period: Delivery & Installation period for the supply& installation of the items would be 20 working days from the effective date of Supply Order. Please note that Supply order can be cancelled unilaterally by the buyer in case the items are not received within the contracted delivery period. Extension of contracted delivery period will be at the sole discretion of the buyer.

Penalty for use of Undue influence: The Seller undertakes that he has not given, offered or promised to give, directly or indirectly, any gift, consideration, reward, commission, fees, brokerage or inducement to any person in service of the Buyer or otherwise in procuring the Contracts or forbearing to do or for having done or forborne to do any act in relation to the obtaining or execution of the present Contract or any other Contract. Any breach of the aforesaid undertaking by the Seller or any one employed by him or acting on his behalf (whether with or without the knowledge of the Seller) or the commission of any offers by the Seller or anyone employed by him or acting on his behalf, as defined in Chapter IX of the Indian Penal Code, 1860 or the Prevention of Corruption Act, 1986 or any other Act enacted for the prevention of corruption shall entitle the Buyer to cancel the contract and all or any other contracts with the Seller and recover from the Seller the amount of any loss

arising from such cancellation. A decision of the Buyer or his nominee to the effect that a breach of the undertaking to the Seller. breach of the undertaking had been committed shall be final and binding on the Seller. Liquidated Damages (LD): if the vendor fails to complete in full, all deliveries of all items and within the stipulated period, the vendor shall pay to the customer Liquidated Damages at the rate of zero point five percent (0.5%) of the total value of supply order of the delayed / undelivered items for every week of delay or part week, subject to the maximum value of the liquidated damages being not higher than ten percent (10%) of the value of delayed/undelivered items.

Termination of Contract. 16. The Buyer shall have the right to terminate the Supply order/ Contract in part or in full in any of the following cases:-

(a) The delivery of the services is erratic, the manpower provided do not work or yield the desired result of work, indulges in the unauthorized congregation, theft, damaging of Army/ Govt / Institute property and any other unauthorized activity which is an impediment to smooth functioning or a security or a fire hazard.

(b) The Seller is declared bankrupt or becomes insolvent.

The delivery of services is not up to the required standard and the manpower (c) provided do not have sufficient proof of their character and antecedents.

17. Payment Terms: Army Institute of Management Kolkata will process the payment after verifying the accuracy of the work, along with receiving the Water Test report from a NABL accredited lab, as outlined in paragraph 12 of the RFP.

Warranty terms: Warranty terms (Minimum 1 year Onsite for all items.) should be 18. mentioned in yourQuotation along with service details.
