- 2. Interested vendors/agencies are kindly requested to submit their quotations along with a list of refreshment items, hot and cold beverages, including their respective rates. Experience in quick service restaurant will be preferable.
- The sealed quotation should be submitted in the Tender Box (located at the reception
  of the administrative building, AIMK) on the company's official letterhead, bearing the office
  seal and the signature of the authorized representative, along with their full name, designation,
  and contact number, not later than 1200hrs on 21 April 2025.
- 4. Quotation is to be submitted during working hours only (i.e 09.30AM to 04.30PM) and an entry with date of submission of your quotation be endorsed in the register kept at reception area. It is a mandatory requirement for acceptance of quotations. Quotations, without the entry in the register, will be rejected. Quotations sent through speed post will also be accepted.

  - Details of registration/Trade License. (a)
  - (b) PAN/TAN Card.
  - (c) GST Registration Certificate.
- Terms and Conditions: The following terms and conditions must be adhered to: -
  - Refreshments: The following types of refreshments are permitted: -(a)
    - (i) Vegetarian items.
    - (ii) Non-vegetarian items.
    - (iii) Hot and cold beverages.
  - Alcohol and Tobacco Products. Alcoholic drinks and tobacco products are strictly prohibited in the cafe.
  - Electricity. AIMK will provide a sub-meter for electricity usage, and the vendor will be charged based on the actual consumption recorded by the sub-meter.
  - Operating Hours. The café will operate from 0700hrs to 0900hrs and 1600 hrs to 2200 hrs, subject to demand.
  - Space and Amenities. AIMK will provide well-furnished space (45ft x 33ft) with fire proof for the cafe along with the following amenities: -
    - Four Air Conditioners. (i)
    - Four sofa sets with two center tables. (ii)
    - A sufficient number of chairs and tables are available. (iii)
    - (iv) Two CCTV cameras.
    - (v) One dustbin.
    - (vi) One serving counter.
    - A well-furnished cooking area with a kitchen chimney. (vii)
    - (viii) A deep freezer with a stabilizer.
    - (ix) Five ceiling fans.
    - A music system with four speakers. (x)
    - Wi-Fi facility is also available in the cafeteria. (xi)
  - The rent for the above mentioned space and amenities will also be Rent. mentioned in the sealed quotation.
  - Maintenance. The vendor is solely responsible for the maintenance, cleanliness, and hygiene of the café area. The vendor must assign sufficient staff to ensure proper
  - (h) Outside Personnel. The entry of outside personnel is strictly prohibited.
